- a) From the office of the Executive Engineer (E/M)/GAP-I, KMW&SA at 164, B.T. Road, Kolkata-700108, only on payment of the cost of such documents by cash/ Demand Draft/Pay Order.
  - b) By sending the cost of such document along with usual postal charges, through Bank Draft of any Nationalized Bank to the office of the undersigned by registered post with AD within the prefixed date as indicated below. It should be clearly noted that no claim towards postal delay in either way would be entertained under any circumstances.
- 3) The Tender Documents are not transferable and the cost of the tender documents is not refundable/adjustable under any circumstances.
- 4) The tender is to be submitted in one part, in a properly sealed cover/ envelope with superscription of Tender Number and brief contents.
